I am writing to bring to your attention a serious matter concerning Ms Shilpa Rana who was employed with Foxhog Ventures India Private Limited from December 2023 until her termination on July 18th, 2024 her employment was terminated after multiple warnings related to financial fraud and misconduct within the organization During her tenure she submitted several apology letters acknowledging her behavior Following her termination our HR department requested that Ms. Rana return all company assets and data Instead of complying she verbally abused both the HR team and myself and A formal complaint was lodged at Barakhamba Road Police Station in response to her actions Subsequently, she apologized once more and assured us that she would not repeat such behavior However on July 12th 2024 Ms Rana escalated her misconduct by coming to my home issuing threats and attempting theft Another complaint was filed at the Barakhamba Road Police Station Once again her sister intervened apologizing on her behalf which led me to refrain from taking further action at that time Despite these incidents and repeated opportunities for resolution Ms. Rana has not returned the company assets as required by her employment agreement The final settlement of her last month salary has been withheld pending the return of these assets. Today Ms. Rana has taken her actions a step further by abusing and posting defamatory content on LinkedIn and WhatsApp
